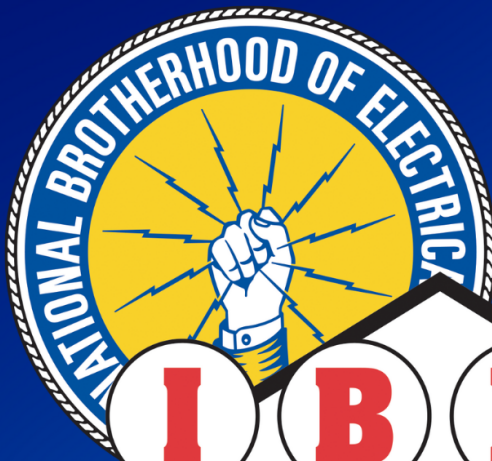

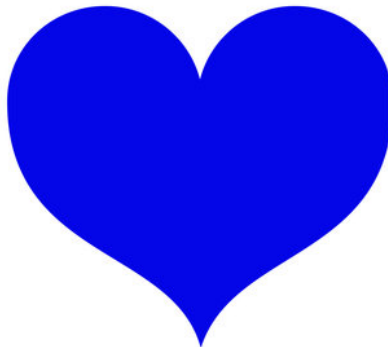

State Ballot Questions

LRCA Question 1: Remove the constitutional status of Board of Regents - which governs, controls, and manages the state universities in Nevada - thereby allowing the state legislature to review and change the governing organization of the state universities.

LRCA Question 2: Revise language in the state constitution related to public entities that benefit individuals with mental illness, blindness, or deafness.

CICA Question 3: Provide for open top-five primaries and ranked-choice voting for general elections.

LRCA Question 4: Repeal language from the Nevada Constitution that allows the use of slavery and involuntary servitude as criminal punishments.

LRSS Question 5: Amend the Sales and Use Tax of 1955 to provide a sales tax exemption for child and adult diapers.

CICA Question 6: Right to Abortion Initiative. Provide for a state constitutional right to an abortion, providing for the state to regulate abortion after fetal viability. **Red Rock Democratic Club Executive Board strongly urges a YES vote on this.**

CICA Question 7: Proposes to amend the Nevada Constitution to require voter ID. **Red Rock Democratic Club Executive Board strongly urges a NO vote on this.**

LRCA = Legislatively Referred Constitutional Amendment
CICA = Citizen's Initiative Constitutional Amendment
LRSS = Legislatively Referred State Statute
